State Bank of India Multi Option Payment System (SBI MOPS Gateway): Bidders are required to avail Internet Banking Facility for making tender remittances in eProcurement System. **Only INTERNET BANKING remittance is allowed.**

No other mode of payment is allowed. (Bidder should ensure that Tender document fee including GST and EMD are remitted as one single transaction and not separate. **Separate or split remittance will be treated as invalid transactions**). The pre-qualification/technical bid shall be opened online at the office of the Chief Engineer (Renewable Energy & Energy Savings), 9th Floor, VidyuthiBhavanam, Pattom, Thiruvananthapuram on the date and time mentioned above in the presence of the bidders/ their representatives who wish to attend. All other existing conditions related to the tenders of KSEB Ltd will be applicable to this tender also. The tender details will also be available in the KSEBL website 'www.kseb.in'.

The bid shall be valid for 180 days reckoned from the date of opening of bid. No queries will be entertained after the pre bid meeting. There will be no negotiation of price once the bid is submitted and the price shall be firm. No correspondence would be made with the bidders once the bid is submitted. The bidder shall visit the site before submitting the bid preferably before the pre bid meeting. The decision taken in the PQ Committee will be final.
