NOTES :-

- (a) The contractor enlisted **upto two classes below the eligible class** may also apply / bid. Application from **two classes** below eligible class applicants may also be considered in the event of inadequate response from the applicants of eligible class and one class below eligible class.
- (b) (i) Applications / bids not accompanied by scanned copies of requisite DD / Bankers Cheque towards cost of tender and Bid Securing Declaration (as applicable) shall not be considered for validation of 'T' bid and their finance bids will not be opened.
- (ii) Tenderers / bidders to note that they should ensure that their original DDs and Bid Securing Declaration (as applicable) are received within **05 days** of bid submission end date.
- (iii) In case of applications / bids from enlisted contractors of MES, where scanned copies of requisite DD / Bankers Cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date, finance bids will be opened. However, non-submission of physical copies of cost of tender shall be considered as willful negligence of the bidder with ulterior motives and such bidder shall be banned from bidding for a period of six months commencing from the date of opening of finance bid.
- (iv) In case of applications / bids from unenlisted contractors, where scanned copies of requisite DD / Bankers Cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date, finance bids will not be opened. Name of such contractors alongwith complete address shall be circulated for not opening of their bids for a period of six months commencing from the date of opening of finance bid.
- (v) In case of applications / bids (enlisted contractor as well as unenlisted contractor) where scanned copies of requisite Bid Securing Declaration (as applicable) were uploaded but the same are not received in physical form within stipulated time, such bids shall not qualify for opening of finance bid.

(c) Contractors enlisted with MES shall upload following documents for checking eligibility:-

(v) Details of **similar nature of works executed during last seven years as detailed in 8 C (i) here-in-before**, financial year-wise in tabular form giving name of work, Accepting Officer's details, viz, Address, Telephone, Fax No, E-mail ID etc, date of acceptance of tender and actual date of completion. This shall be duly signed by proprietor / all partners / authorised Director of Pvt / Public Ltd, as applicable. It should indicate whether extension was granted or compensation was levied. Attested copy of acceptance letter and completion certificate shall be enclosed of each work. In case performance report has been given by the client, same shall also be submitted duly attested.

(d) Contractors not enlisted with MES will be required to upload necessary documents to prove their eligibility for enlistment in eligible class & category of work, including Affidavit for no recovery outstanding. List of documents required for enlistment in MES has been given in para 1.5 of section 1 of Part I of MES Manual on Contracts 2007 (Reprint 2012). The following documents shall also be uploaded amongst others:-

(i) Details of **similar nature of works executed during last seven years as detailed in 8 C (i) here-in-before**, financial year-wise in tabular form giving name of work, Accepting Officer's details, viz, Address, Telephone, Fax No, E-mail ID etc, date of acceptance of tender and actual date of completion. This shall be duly signed by proprietor / all partners / authorised Director of Pvt / Public Ltd, as applicable. It should indicate whether extension was granted or compensation was levied. Attested copy of acceptance letter and completion certificate shall be enclosed of each work. In case performance report has been given by the client, same shall also be submitted duly attested.

(ii) Solvency Certificate and Working Capital Certificate issued by Scheduled bank.

(iii) Annual turnover certificate for last 2 years issued by Chartered Accountant along with relevant pages of audited balance sheets in support thereof.

(iv) In addition, the un-enlisted contractors shall also furnish affidavit on non Judicial stamp paper in the form of hard copy declaring their turnover for last 2 (Two) years.

(v) Scanned copy of DD towards cost of tender and Bid Securing Declaration.

(vi) MOU with Solar power firm with approval letter.

or

Solar power firm approval letter in the name of firm.

(e) In case of rejection of technical /prequalification bid, contractor may appeal prior to opening of financial bid to next higher Engineer authority ie. Chief Engineer Jaipur Zone on email cezjpr2-mes@nic.in against rejection, whose decision shall be final and binding. However contractor / bidder shall not be entitled to any compensation whatsoever for rejection of technical / prequalification bid.

(f) Keeping in view the applicability of GST on all contracts, it is mandatory for the contractors to upload their GST Registration Number alongwith the 'T' bid. This will be one of the criteria for qualifying in 'T' bid. Contractor, who does not upload GST registration No. shall be disqualified in the 'T' bid evaluation and his Financial bid shall not be opened.

(g) The Contractor shall also ensure compliance of the EPF & MP Act, 1952 by the sub-contractors, if any engaged by the contractor for the said work with prior approval of competent authority.

(h) Court of the place from where tender has been issued shall alone have jurisdiction to decide any dispute out of or in respect of this tender. After acceptance of tender, Condition 72-Jurisdiction of Court of IAFW-2249 shall be applicable.

(j) Before quoting the tender, Contractor can visit the site with prior permission of GE concerned to acquaint himself about the site conditions and nature of work to be executed. The Contractor shall also study the tender documents carefully and any discrepancy / clarification / suggestion on tender documents required shall be brought to the notice of Accepting Officer and got clarified before bid submission start date.

(k) **“Performance Security** :- The successful contractor shall deliver a performance security in the prescribed form for an amount equivalent to 3% of the contract sum to the Accepting officer within 28 days of receipt of the letter of Acceptance in terms of condition 19 of IAFW-2249”
